

## **Scholarship Details:**

Entry Period: The \$5,000 #FlyToSuccess Stratus Financial Scholarship (the "Scholarship") begins at 8:00:00 AM Pacific Time ("PT") on Monday, January 08, 2024, and ends at 11:59:00 PM Pacific Time ("PT") on Friday, June 21, 2024. The official Scholarship announcement will be made Friday, July 26, 2024, at Airventure OshKosh 2024. The \$5000 scholarship will be paid directly to the flight school of the winner's choice in the US or Puerto Rico. The \$5,000 Stratus Financial Scholarship is only open to legal residents of the United States and Puerto Rico age 17 or older and who meet the following eligibility requirements at the time of entry:

## Eligibility:

- Student must be currently enrolled in a flight school with 25 flight and/or ground school hours provided by the flight school logged.
- Student must be a legal resident of the United States.
- Student must be over 17-years-old.
- Student must fill out entry form on Stratus. Finance/Scholarship website including answers to the two essay questions.
- Student must film a short-form video using the hashtags #FlyToSuccess and #StratusFinancial on what flying to success means to them and how it aligns with their journey.

ENTRY: There is (1) way to enter.

Method #1: Online Entry: Participants may enter by visiting the Scholarships Online Landing Page at www.Stratus.Finance/Scholarship completing the online entry form and recording a short-form social media video using the hashtags #StratusFinancial and #FlyToSuccess. Submitting to receive one (1) Scholarship Entry (the "Entry") per entry period. Entries must be received between Monday, January 08, 2024 at 8:00:01 AM Pacific and Friday, June 21, 2024 at 11:59:59 PM Pacific. Entrants are subject to all notices posted online including but not limited to Stratus Financial's Privacy Policy. Limit: One (1) Entry per person.

<u>ENTRY WINNER:</u> One (1) winner will be selected by Stratus Financial's Executive team whose decisions are final and binding in all matters related to this Scholarship. Winner will be selected based on successful completion of requirements, verified flight training status, compelling essays, and videos. The winner will be announced at EAA AirVenture OshKosh on Friday, July 26, 2024.

<u>WINNER NOTIFICATION & VERIFICATION:</u> Potential Grand Prize winner will be notified via email and/or phone, and will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These Releases will require the Grand Prize winner to furnish his/her Social Security Number for the sole purpose of tax reporting, as required by law.



The Winner will also be required to submit proof of enrollment and 25 minimum credit hours at a flight school located within the United States or Puerto Rico before prize is awarded. Noncompliance will result in disqualification and an alternate winner may be selected. The prize will be awarded within approximately 45 days after the winner is verified. The Grand Prize winner will also be required to provide his/her social media handles as requested by Sponsor and to submit to a background check to confirm eligibility and help ensure that the use of any such person in advertising or publicity for the Scholarship will not bring Sponsor into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the Scholarship or Sponsor, as determined by Sponsor in its sole discretion.
